

ADULT DRIVER
CHURCH OWNED OR CHURCH RENTED VEHICLES
LEGAL RELEASE AND INDEMNIFICATION AGREEMENT

Please carefully read the following agreement before you sign. These guidelines have been established to protect you, your passengers, and the church. Upon completion attach a copy of your driver's license and insurance card.

In consideration of the undersigned's participation in programs and activities organized by Southeast Christian Church of Jefferson County, Kentucky, Inc. (the "Church") and as an inducement to organizing activities including driving Church owned or rented vehicles ("Activity") and permitting the undersigned's participation therein, the undersigned agrees as follows:

The undersigned wishes to drive church owned or a church rented vehicle to the Activity and possibly transport participants to an Activity; the undersigned hereby warrants that he/she is an insured driver with liability insurance and is at least 25 years of age and under 70 years of age; the undersigned agrees to ensure that the driver and all passengers wear seat belts.

The undersigned hereby fully and forever releases and waives and agrees not to bring or cause to be brought any and all claims, demands, actions, or causes of action of every possible kind and nature whatsoever the undersigned might assert, including, without limitation, claims for personal injury, wrongful death, or property damage, whether or not absolute, known or unknown, or otherwise against the Church or any of its elders, officers, employees, representatives, agents and volunteers (collectively referred to herein as the "Releasees") by reason of, arising out of or relating to the undersigned's participation in the Activity. The undersigned releases the Releasees and waives all such claims against the Releasees for any injuries or damages caused in any manner whatsoever whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees by reason of, arising out of or relating to the Activity or the undersigned's driving to or from the Activity.

The undersigned further agrees to indemnify, defend and hold the Releasees harmless from any kind of compensatory or punitive damages sought to be recovered from the Releasees and all losses sustained by the Releasees independent of claims asserted by others, including, without limitation, general damages, property damage, special, incidental and consequential damages, losses or expenses suffered or paid, directly or indirectly, as a result of any and all claims, causes of action, suits, proceedings, demands, judgments, assessments, and liabilities, including reasonable attorneys' fees incurred in litigation or otherwise, assessed, incurred or sustained by or against the Releasees by reason of, arising out of or relating to the Activity or the undersigned's driving to or from the Activity.

The undersigned further agrees that the execution of this Agreement is continuing in nature; it is my knowing and voluntary act; I am under no duress or undue influence to execute this Agreement; I further agree that I have read and understand this Agreement; this Agreement is binding upon me and my heirs, executors, administrators and legal representatives; it is my intention with this Agreement to make a complete, general, and unconditional release of any and all claims whatsoever against the Releasees, as set forth above; I authorize the Church to perform a Department of Motor Vehicles check now and in the future and release such information to the Church; at no time shall anyone else operate the vehicle; I will only use the vehicle for Church purposes; I will properly lock the doors and windows when the vehicle is unattended; I will not be under the influence of alcohol or drugs when operating the vehicle; I will return the vehicle clean of trash and personal items; I will immediately notify my supervisor of any accident, minor or major; I will not use the vehicle for any purpose that could be charged as a crime, to push another vehicle or participate in a speeding contest; I will be responsible for the vehicle if it is lost or damaged; I accept full responsibility for parking and traffic violations and fines.

This Agreement shall be effective from the date signed below until the date of receipt of a written declaration signed by the undersigned, that this Agreement shall no longer be effective with regard to any Activity from and after the date of the receipt via U.S. Mail of the written declaration addressed to Southeast Christian Church of Jefferson County, Kentucky, Inc., 920 Blankenbaker Parkway, Louisville, KY 40243-1845, attention: General Counsel.
